 - Promised to report in public about the activities




Overview (cont.)

Objectives

- Revitalizing the historically allocated address space
- Providing the challenge field for coming IPv6
 - Boosting up development of the "end-to-end" application
 - Exploring new services and business
 - Transferring trial to IPv6 infrastructure with the practical application and service
 - Forming IPv6 address administration scheme in JP

Overview: Trial Usage IPv4 Address space handling

- The historical space allocated from IANA is utilized.
- Allocation to LIR is restricted in time of use by the contract
- All address must be returned by the end of 2005 (transfer to IPv6)
 - The returned address will be returned to free block
- JPNIC supervise the registry work of IPv6 PC of Japan



Activity Update

- Documentation completed
 - Basic Policy
 - Detailed is explained last time
 - Contracts have been completed.
 - "Time-limited Lease" condition
 - Detailed is explained last time as well.
- Registry work started
 - Allocation Status can be publicly referenced.
 - Reverse-DNS has been set up (ns1/ns2.v6nic.net)

- Contracts made with the following application area of Participants:
 - Large ADSL/VoIP service
 - Public Space "Hot Spot" (wireless) service
 - Contents Delivery service
 - "Always-On" connection service for Internet games, Internet Phone
 - PPP connection service for Home Appliances



Program timetable

- First phase :
 - December 31, 2001 (completed)
 - Allocated 23 /16s out of 43/8 block
- Second phase :
 - January 1, 2002 -December 31, 2002
 - Examination of extending the program
 - The allocated IPv4 address space must return before December 31, 2005.
